Variable Heights

- Increments of 1.6m rises
- Maximum allowable height of 3.6m not tied in, tie tubes and supporting structure are required to be fitted
- Maximum distance between ties is 3.9m refer to AS/NZS4576-1995 (guidelines for Scaffolding) for guidelines on tying to supporting structures
- Toe Boards fitted
- Top Level internal handrail is fitted with an exit rail to prevent falls
- Scaffold Tags/Hand over certificates are provided on completion of installation
